It is a specially authorized state body that carries out attestation and state accreditation educational of institutions.

## 3) How long does the procedure take?

#### Certification

The main form of state control in the evaluation of the activities of the educational institution is to determine the content, level and quality of training in the educational institution in accordance with state educational standards and state requirements.

#### **Accreditation**

Recognition by the state that an educational institution meets the criteria and requirements of state educational standards and state requirements, as well as the right of its graduates to submit documents on the information approved by the state.

Educational institutions are certified **every 5 years**. Newly established educational institutions will be certified after 5 years.





## 4) What is the list of the documents needed for accreditation in Uzbekistan?

In the process of attestation (certification), a comprehensive analysis of the activities of educational institutions over the **past two years** by types of education, mainly the organization of the educational process in accordance with state educational standards and state requirements, education of students and pupils. Particular attention is paid to the level of mastering the programs, the potential of the teaching staff, the conduct of educational work and the provision of textbooks to students.

Based on the project proposal, it is enough accredited by National level.




